Your feedback will help inform our plans for the overall project, in particular on two separate applications which will allow the project to proceed. The first application will likely be to An Bord Pleanála (ABP) and will be for the Onshore Grid Infrastructure required to connect the wind farm to the national grid. The second application is to the Department of Housing, Planning and Local Government (DHPLG), which oversees our foreshore lease to develop the offshore wind farm, and is an application under our foreshore lease requesting permission to construct the Offshore Infrastructure required for the wind farm.

In 2021 we will advertise and launch a separate consultation process to get local feedback on the proposed Operations and Maintenance Facility and to refine our plans prior to submitting the final planning application(s) for the facility.

We commit to keeping you informed as the project develops and will endeavour to seek your feedback in relation to key project activities. We welcome your feedback during this consultation process and throughout the project lifecycle.
