## Eligibility

The funding is available to community groups within 12 miles of the Bin Mountain and Tappaghan wind farm with a preference given to those within 3 miles of the windfarm .

## Fund Deadline

Applications close on Friday 9th December at 5pm.

## What can the fund be used for?

Funding is available for projects with a focus on energy efficiency, social and environmental sustainability, safety and tourism and recreation. Support is also available for projects that will help rebuild our community in the months ahead following the COVID 19 pandemic.

## Fund criteria

The fund is open to projects within 12 miles of the windfarm

Priority will be given to applications which:

- Are within 3 miles from the windfarm

## The fund is unable to support

- Projects which do not benefit people living within 12 miles from the wind farm
- Individuals
- The advancement of religion or politics
- The repayment of loans or payment of debts
- Costs already incurred or activities which will take place before we have decided on an application (retrospective funding).
- Payments towards activity which is the responsibility of statutory authorities.
