# MAJOR PROJECTS FUND

## 2022-2024 Application Form

## What is the Major Projects Fund?

SSE Renewables and Greencoat Renewables created the Major Projects Fund as part of its voluntary community benefit arrangements from its onshore renewable energy development at Galway Wind Park. Projects applying should be located within 10km of the Galway Wind Park and aim to improve or enhance the local infrastructure, landscape, biodiversity, heritage, or sports and recreation and make a lasting difference to the places where residents live, work and visit.

### Who can apply to the fund?

To be eligible for funding, your project must be 'shovel ready' and benefit communities that lie within 10km of Galway Wind Park. You don't need to be a registered charity to apply, but your organisation must be not-for-profit.

### What is the fund value and timescale?

In this round the fund is worth a total of €300,000 for years 2022 & 2023. You can apply for funding of €20,000 to a maximum of the fund's total value. Certain projects maybe eligible for multi year funding over 5 years.

Fund opens for applications on Monday 21st March 2022

Closing date for applications is Friday 29th April 2022

### What are the aims of the fund?

The fund is to be used to provide support for strategic projects within 10km of Galway Wind Park and any successful application must meet one or more of the following outcomes:

- **Empowering communities:** Empower communities to become more resilient through measures which demonstrate safety, long-term social, environmental or economic improvements.
- **Sustainable places :** Stimulate meaningful regeneration to improve or enhance the local infrastructure , landscape , biodiversity , heritage , or sports and recreation and make a lasting difference to the places where residents live, work and visit.

## What are the scoring panel looking for?

The panel will review the application based on its relevance to the priority themes identified above and appraise the safety, social, economic and environmental impact it could have to the local area. This will be the primary form of assessment. The panel will be looking for projects with the potential for transformational change. **Projects must be 'shovel ready' with permissions and legal agreements already in place. For this year, the Panel have an interest in projects which will enhance the local economy as communities recover from the coronavirus pandemic.**

Additional consideration will be given to projects that demonstrate:

- **Value for money** – evidence that the project has a high local impact for the amount invested.
- **Co-funding** – funding from the community or other organisations.
- **Community involvement** – evidence that the community has been engaged in developing the project. This may be in the form of surveys, community consultations, open days or letters of support.
- **Financial Sustainability** – evidence that the project will be maintained beyond the period of grant funding.
- **Contribution to local economy** – evidence that the project will have a positive impact on the local economy in the long term.

## What is expected of funded projects?

- Each funded project will gain the support of the Community Fund Team to provide advice and guidance as required.
- Any grant received should begin drawing down spend within one year of being awarded. Long-term projects (such as building work or multi-year projects) will be released in stages and must demonstrate progress within one year of award.
- SSE Renewables and Greencoat Renewables are committed to understanding the social impact of the fund. One of the key requirements of successful applicants is to monitor and evaluate your project.
- Applicants will be asked to identify outcomes at the start of the funding and confirm outcomes at the end of project. We require successful applicants to provide copies of evaluation activity to the Community Fund Team.

## What is not eligible for funding?

- Projects which do not meet the Major Projects Fund criteria.
- Projects which are not geographically located within 10km of Galway Wind Park.
- Individuals, or groups which are not registered as not-for-profit.
- The advancement of religion or politics (including requests to support the core activities of religious or political groups).
- Direct costs of energy consumption.
- The repayment of loans or payment of debts.
- Trips abroad.
- Costs already incurred or activities which will take place before we have made a decision on an application (retrospective funding).
