Eligibility

The fund is open to applications from not for profit groups located within 20 kilometres of the wind farms, with priority given to groups within 5 kilometres.

Fund deadline

Fund Opens on Monday 27th September and will close at 5pm Friday 15th October.

What can the fund be used for?

Volunteer groups providing emergency assistance to the vulnerable in response to the COVID-19 pandemic can apply for funding. Support is also available for projects that will help rebuild our community in the months ahead.

Fund criteria

The fund is open to applications from not for profit community groups within 20 kilometres of the wind farms.

In the event the fund is oversubscribed priority will be given to applications which:

- Are within 5 kilometres from the wind farms

The fund is unable to support

- Projects which do not benefit people living within 20 kilometres from the wind farms
- Individuals
- The advancement of religion or politics
- The repayment of loans or payment of debts
- Costs already incurred or activities which will take place before we have decided on an application (retrospective funding).
- Payments towards activity which is the responsibility of statutory authorities.
