WELCOME TO THE ARKLOW BANK WIND PARK PHASE 2 SUMMER 2022 NEWSLETTER

The first half of the year has flown by and I am delighted to inform you that there has been substantive progress made on the project with a number of key project milestones achieved in recent months in relation to consenting and survey works.

A highlight of the year so far was the SSE Renewables Round Ireland 2022 international sailing event which was delivered in partnership with Wicklow Sailing Club. We have also been pleased again to support a number of exciting and worthy local community projects in the first half of this year through the Arklow Bank Wind Park Phase 2 Sponsorship Fund.

At a national level, as progress continues to be made across the wider industry, SSE Renewables has called for increased national ambition in relation to Ireland's climate action targets and to ramp up the rapid deployment of offshore wind at scale.

There have also been some changes to our own team and as I move to a Public Affairs role across our Irish portfolio, we welcome newly appointed Community Engagement Manager Deirdre Keogh who will lead on local engagement for the project going forward.

PROJECT MILESTONES

Three significant milestones were achieved in relation to Arklow Bank Wind Park Phase 2 in recent months.

The first of these was announced in May as An Bord Pleanála granted planning permission for the Onshore Grid Infrastructure (OGI). The OGI comprises all of the onshore infrastructure required for the project and enables the offshore windfarm to connect into the local transmission system at the Avoca River Park.

The granting of this planning permission was a historic first for the Irish offshore wind industry as it marks the first time a developer has secured planning permission to develop onshore transmission grid infrastructure for an Irish offshore wind farm.

June saw the submission of our Maritime Area Consent (MAC) application to the Department of Environment, Climate and Communications. This consent is sought to secure seabed exclusivity and we expect a decision in the coming months.

Thirdly, we achieved planning permission from Wicklow County Council in relation to our proposed Operations and Maintenance Facility at South Dock in Arklow Harbour. Once operational, this facility with integrated Sustainable Education Centre will support 80 local jobs for the lifetime of the wind farm.




OFFSHORE SURVEY WORKS

We also concluded a successful ground investigation campaign on the Arklow Bank Wind Park Phase 2 site earlier this month. The survey works were conducted at various locations across the site to enable us to gain a clearer understanding of the seabed conditions to support the ongoing engineering design.

The jack up vessel 'Neptune' was on site for a number of weeks to provide marine operations support to the ground investigation Contractor, Fugro, to complete this work.

Further site investigation survey works will be ongoing across the site through August and September and a Notice to Mariners will be issued in advance. Our Fisheries Liaison Officer (FLO) Brendan Dillon will also be engaging directly with commercial fishery stakeholders.



STUDENT MENTORING PROGRAMME

Members of our team were delighted to participate in a successful mentoring programme with students at Glenart College, Arklow during the past academic year. This programme was delivered through Business in the Community Ireland (BITCI) and saw a variety of topics covered at monthly virtual sessions, including CV preparation, goal setting and interview preparation. We wish the students the best of luck in their future endeavours.



NATIONAL OFFSHORE TARGETS INCREASE TO 7GW BY 2030

SSE Renewables welcomes the announcement by Government that the national offshore wind targets for 2030 have been increased from 5GW to 7GW. This is something that we have been vocal about for some time and was the key message that our Director of Development Maria Ryan shared at the recent Energy Ireland conference.

She also stressed the importance of setting interim targets between 2030 and 2050 and ensuring that clear pathways are created for delivery of emerging technologies such as green hydrogen.

Maria reminded delegates that offshore wind will play a key part in the solution to the environmental challenges we are currently facing and support in the delivery of

environmental sustainability, energy security and energy equity.

FISHERIES FUND

We are co-developing a commercial fisheries pontoon in Arklow's South Dock with Wicklow County Council which has now passed through the public consultation process with full approval expected over the coming months. This project will be delivered in partnership with the local authority and is part-funded under the Arklow Bank Wind Park Phase 2 Fisheries Fund.

This initiative will increase the berthing capacity in this area of the dock, it will greatly enhance access and egress safety and also provide services such as electricity and water directly to the fishing vessels.

WICKLOW SUSTAINABLE ENERGY COMMUNITY

We were delighted to be invited to exhibit at the recent Wicklow Sustainable Energy Community masterplan launch event at Wicklow Pastoral Centre. The event was indicative of the local appetite for a more sustainable future for those living and working in Wicklow Town and environs.


