Eligibility

The fund is open to applications from not for profit groups located within 12 miles of the Wind Farm, with priority given to groups within 3 miles.

Fund Deadline

The fund is now open and closes 5pm Monday 28th June 2021.

What can the fund be used for?

Volunteer groups providing emergency assistance to the vulnerable in response to the COVID-19 pandemic can apply for funding. Support is also available for projects that will help rebuild our community in the months ahead.

Fund criteria

The fund is open to applications from not for profit community groups within 12 miles of the wind farm.

In the event the fund is oversubscribed priority will be given to applications which:

- Are within 3 miles from the windfarm
- On a first come first serve basis


The fund is unable to support

- Projects which do not benefit people living within 12 miles from the wind farm
- Individuals
- The advancement of religion or politics
- The repayment of loans or payment of debts
- Costs already incurred or activities which will take place before we have decided on an application (retrospective funding).
- Payments towards activity which is the responsibility of statutory authorities.
