Applications close on Friday 17th June 2022 5pm.

## **Fund criteria**

- Cultural and Linguistic Sustainability
- Youth Development and Wellbeing
- Sustainability
- Safety

In the event the fund is oversubscribed priority will be given to applications within 5km from the windfarm.

#### The fund is unable to support

- Projects which do not benefit people living within 20km from the wind farm
- Individuals
- The advancement of religion or politics
- The repayment of loans or payment of debts
- Costs already incurred or activities which will take place before we have decided on an application (retrospective funding)
- Payments towards activity which is the responsibility of statutory authorities
